

OFFICIAL RULES
CEVA ANIMAL HEALTH INC.
ADAPTIL® SUMMER GIVEAWAY WITH AUZZY & ELLE

1. **ELIGIBILITY:** “ADAPTIL® Summer” Giveaway (“Giveaway”) will take place starting 12:00 AM Eastern Time Wednesday, July 3rd, 2024 and conclude at 8:00 AM Eastern Time on Friday, July 19th, 2024 (“Promotion Period”). The Giveaway will be conducted by Ceva Animal Health Inc. (“Ceva”). The Giveaway is open only to legal residents of Canada who are 18 years of age or older (or the age of majority if older pursuant to applicable legislation), who complete the official entry form. Participants belonging to an organization with an ethics policy that prohibits them from accepting gifts are not eligible to participate. All employees, officers and agents of Ceva, its affiliates, immediate family members (spouse, parents, or children) and those living in the same household of each are ineligible to enter or win the Giveaway. Employees or contractors of any company that sells companion animal products that are directly competitive with Ceva’s companion animal offerings are ineligible to win. Limit of one entry per person; a potential winner will be disqualified if he/she submits more than one (1) entry. Each entry form must contain, at a minimum, Participant’s full name, email address and have opted in to receive email communications regarding this Giveaway to be eligible to win.

2. **DRAWING AND ELIGIBILITY:** Ceva or its designee will randomly draw one (1) prize winner from all eligible entries on or about 2:00 PM EST on July 19th, 2024. Potential winner need not be present to win. A potential winner will be notified by email. A potential winner will be required to correctly answer a mathematical skill-testing question without aid or assistance before being declared a winner. If a potential winner cannot be reached, does not respond or is unable to complete the skill-testing question within seventy-two (72) hours of the initial notification attempt, he or she may be disqualified and the Prize awarded to an alternate winner. Odds of winning depend on the total number of eligible entries received.

3. **PRIZES:** One (1) prize will be awarded.
